The Central Security Depository (CSD) participants are to submit their bids using the CSD bidding option by 10.00am on Tuesday, 17 September 2024. The non-CSD participants are to email their tender forms to tender-markets@rbf.gov.fj by 9.00am on Tuesday, 17 September 2024.

Successful non-CSD participants need to make a direct payment for the full Face Value of the tendered amount through FIJICLEAR to the RBF, evidence of which must accompany all tender forms lodged. If the settlement amount for an accepted tender exceeds the face value, the successful non-CSD bidder is to settle the difference by 1.00pm on Tuesday, 17 September 2024.

On the other hand, for CSD participants once allotment of stock has been made, the settlement for successful bids will be done through the FIJICLEAR by 2.00pm on 18 September 2024.
