The Central Security Depository (CSD) participants are to submit their bids using the CSD bidding option by 10.00am on Tuesday, 25 March 2025. The non-CSD participants are to email their tender forms to tender-markets@rbf.gov.fj by 9.00am on Tuesday, 25 March 2025.

Successful non-CSD participants need to make a direct payment for the full Face Value of the tendered amount through FIJICLEAR to the RBF, evidence of which must accompany all tender forms lodged. If the settlement amount for an accepted tender exceeds the face value, the successful non-CSD bidder is to settle the difference by 1.00pm on Tuesday, 25 March 2025.

On the other hand, for CSD participants once allotment of stock has been made, the settlement for successful bids will be done through the FIJICLEAR by 2.00pm on 26 March 2025.
