

INVITATION TO TENDER



RE-OPENING OF 15 YEAR 6.50% FIXED COUPON FIJI INFRASTRUCTURE BOND TO BE HELD ON 07 March 2018.

The Reserve Bank of Fiji, on behalf of the Government of Fiji, invites tenders for the above Government Bond with details below: -

Tenor	15 –Years
Amount Floated	\$30.0 million
Coupon	6.50%
Yield	Yield to be quoted into a maximum of two decimal places e.g. 1.05%
Yield to Maturity	6.48% (as at 28/02/2018)
Maturity	20 September 2032
Interest Dates	20 March & 20 September in each year until maturity
Day count convention	Actual/Actual

Minimum (Non-Competitive Tender) : \$1,000 (face value); thereafter multiples of \$1,000 (face value). Maximum tender is \$100,000 per maturity.

Minimum (Competitive Tender) : \$10,000 (face value); thereafter multiples of \$1,000 (face value) per maturity.

Tenders are to be lodged in the Tender Box at Tower 2, Reserve Bank of Fiji Building, Suva between the hours of **9.00am to 3.00pm on 05 March 2018 and from 9.00am to 12.00pm on 06 March 2018**. Allotments will be notified on 06 March 2018.

Payment by bank cheque for the full face value of the amount tendered must accompany each tender lodged. If the settlement amount for an accepted tender exceeds the face value, the successful bidder is to settle the difference by **12.00pm on Wednesday, 07 March 2018**.
