

FIJI INFRASTRUCTURE BONDS



The Reserve Bank of Fiji, on behalf of the Government of Fiji, invites tenders for the issue of Fiji Infrastructure Bonds up to a limit of **\$10,000,000** as follows: -

15 years due date on 12/04/2032 (redeemable at par between 12/04/2028-2032)	7.07% p.a

Minimum (Non-Competitive Tender) : \$50 (face value); thereafter multiples of \$50 (face value). Maximum tender is \$100,000 per maturity.
Minimum (Competitive Tender) : \$10,000 (face value); thereafter multiples of \$1,000 (face value) per maturity.

Coupon Rate : To be determined by the weighted average yields of accepted competitive tenders.

Tenders are to be lodged in the Tender Box at Tower 2, Reserve Bank of Fiji Building, Suva between the hours of **9.00am to 3.00pm on 10 April 2017 and from 9.00am to 12.00pm on 11 April 2017**. Allotments will be notified on 11 April 2017.

Payment by bank cheque for the full face value of the amount tendered must accompany each tender lodged. If the settlement amount for an accepted tender exceeds the face value, the successful bidder is to settle the difference by **12.00pm on Wednesday, 12 April 2017**.
